4. Is a sole trader or a micro enterprise with an annual turnover of less than £2m.
5. The equipment being hired will not be used for processing, handling or recycling waste, nor will it be used at any premises where these activities are occurring.
6. The limit of liability provided by this insurance is £50,000 which is sufficient to cover the items being hired.
